According to the vital statistics of the Ministry of Health, Labor and Welfare, the number of divorces in 2017 was 210,000, and the number of divorces of parents with children was about 130,000.

In addition, about 75% of single-parent households, 680, 000 households do not receive child support, of which about 44% of mother-child households are non-regular employees, and financial problems are becoming more serious.

Under these circumstances, the amendment of the Civil Enforcement Law in April 2020 has made it easier to carry out assets disclosure procedures and to claim unpaid child support.

Through the rent guarantee business Casa provide support through consultation desks when tenants have problems with their lives, and housing support in collaboration with the government and food banks.

Utilizing the know-how cultivated in such rent guarantee business, in addition to guaranteeing child support, Casa support single-parent households, room and job search, aiming for an environment where single parents and children can become independent together.
