The reason for the Board of Corporate Auditors nominated Akari Audit Corporation as a candidate for the accounting auditor was, having experience in auditing a listed company, the expertise, independence and quality control system required for an accounting auditor suitable for the business scale of the Company.

6. Reasons for the decision to change or reasons leading to the change

The official term of Deloitte Touche Tohmatsu LLC, the Company's current accounting auditor, will expire at the close of the 7th Annual General Meeting of Shareholders scheduled for April 23, 2020.

In response to the request from the auditing firm for an increase in audit fees, the Company has been examining the appropriateness of audit response and audit fees reasonableness to the business scale. As a result, Akari Audit Corporation is newly appointed as an accounting auditor.
